What is the BLACK Course?

This year at Challenger 7, we've replaced the Green Course with an ultralong Black Course that's almost twice as long as a typical Orange Course. We estimate winning times will be in the 70-80 minute range on this course. (NOTE: All competitors still must complete the course within the 3-hour time limit.) If you've been successful and fast competing on an Orange Course and want an extra challenge, register for the ultralong BLACK Course!
